## Ed Edmonds - Revised July 16, 2013

July 31	Trading deadline - last day to trade a player without securing waivers, 4:00 p.m. EDT.
August 14-15	Owners meeting - Cooperstown, New York.
August 29	Unconditional release waivers must be requested by 2:00 p.m. EDT to avoid May 15, 2014, signing restriction.
September 1	Active rosters expand to forty players.
September 29	Last day of the regular season.
Sept. 30 - Oct. 15	Article XX(D) free agency period.
October 23	First day of the World Series.
November TBA	Deadline for teams to make qualifying offers to their eligible former players who became XX(B) free agents, fifth day after World Series is completed, 5:00 p.m. EDT.
November TBA	Deadline for XX(B) free agents to accept qualifying offers, twelfth day after World Series; 5:00 p.m. EST.
November 11-13	General managers meeting - Orlando, Florida.
December 2	Tender deadline - last day for teams to offer 2014 contracts to unsigned players.
December 2-5	Major League Baseball Players Association executive board meeting - La Jolla, California.
December 9-12	Winter Meetings - Lake Buena Vista, Florida.
December 12	Major League Rule 5 Draft.

#### 2014

January 14	Salary arbitration filing.
January 17	Salary arbitration figures exchanged.
February 1-21	Salary arbitration hearings - St. Petersburg, Florida.
February 13	Voluntary reporting date for pitchers, catchers and injured players.
February 18	Voluntary reporting date for other players.
February 25	Mandatory reporting date.
March 12	Last day to place a player on unconditional release waivers and pay thirty days termination pay instead of forty-five days.
March 22-23	Los Angeles Dodgers versus Arizona Diamondbacks - Sydney, Australia.
March 26	Last day to request unconditional release waivers on a player without having to pay the full salary for the 2014 season.
March 30	Opening day. Active rosters reduced to twenty-five players.
July 15	All-Star game - Target Field, Minneapolis, Minnesota.
July 18	Deadline for amateur draft picks to sign contracts.
July 31	Trading deadline - last day to trade a player without securing waivers.
September 1	Active rosters expand to forty players.
December 2	Last day for teams to offer 2015 contracts to unsigned players.
December 8-11	Winter Meetings - San Diego, California.
