in 1903. Subjects taught: "Common-Law Pleading," "Criminal Law and Procedure," "Equity Pleading," and "Mortgages." Author of the article on "Judicial Sales" in volume 24, *Cyclopedia of Law and Procedure*.

**HARRIS, Willis Overton, Dean of the Louisville Law School.**—Born in Mill Quarter, Virginia, February 5, 1847. Son of Hilary Harris and Phoebe Ann Harris. Graduated from University of Virginia in 1868 with degree of B. L. Married Caroline Adams on November 22, 1877. Admitted to the Bar of Virginia in 1868. Judge of the Louisville Law and Equity Court. Appointed Professor of Law in the University of Louisville in 1887, and in 1890 was elected Dean of the law faculty of that school. Subjects taught: "Constitutional Law," "Criminal Law," "Real Property," and "Torts."

**HOGATE, ENOCH G., Dean of the Indiana University Law School.**—Born in Centreton, N. J., September 16, 1849. Son of Jonathan Hogate and Sarah Hawthorn Hogate. Graduated from Allegheny College with degree of A. B. in 1872, and with that of A. M. in 1875. Married Anna Huston August 10, 1881. Admitted to the Bar of Indiana in 1872. Clerk of the Circuit Court of Hendricks County, Indiana, 1888 to 1892. State Senator in Indiana, 1896 to 1900. Professor of Law at Indiana University since 1903. Elected Dean of the law faculty of that school in 1906. Subjects taught: "Equity" and "Public and Private Corporations." Author of "Hogate's Indiana Pleading and Practice, 1907."

**HOGG, Charles Edgar, Dean West Virginia University Law School.**—Born in Mason County, West Virginia, December 21, 1852. Son of James Abney Hogg and Susan Knight Hogg. Graduated from Temple University, Pennsylvania, with degree of LL. D. Married Nannie Hawkins June 2, 1882. Admitted to the Bar of West Virginia in 1875. County Superintendent of Schools of Mason County, West Virginia, from 1875 to 1879. Presidential Elector from West Virginia in 1884, and Member of Congress from 1887 to 1889. Elected Dean of the West Virginia University Law School in 1906, and has continued as such to date. Subjects: "Agency," "Corporations," "Constitutional Law," "Criminal Law and Procedure," and "Insurance." Author of works on "Common-Law Pleading" and "Equity." Also of articles on "Conclusive Evidence," "Documentary Evidence," "Judgments," and "Sales," which are published in the *Encyclopedia of Evidence*.

**HOPKINS, Evan Henry, Dean of the Western Reserve Law School.**—Born in Johnstown, Pa., November 4, 1864. Son of David J. Hopkins and Mary Jeffreys Hopkins. Graduated from Adelbert College in 1889 with degree of A. B., and from Harvard University in 1892 with degree of LL. B.

Married Frances P. M. Shain December 27, 1892. Admitted to the Bar of Ohio in 1891. Secretary of the Cleveland Public Library Board, 1892 to 1898. Member of the Cleveland Park Commission from 1900 to 1901. Professor of Law and Registrar in Western Reserve University, 1892 to 1895. Dean of the law faculty of same school since 1895. Subjects taught cover practically the entire law school course.

**HOYNES, William, Dean of the Notre Dame University Law School.**—Born in 1849. Son of P. H. Hoynes and Catherine Hoynes. Received education at Michigan and Notre Dame Universities. Admitted to the Bar of Michigan in 1872, and of Illinois in 1877. Indian Commissioner, 1889 to 1890. Member of the 20th Wisconsin Volunteers during the Civil War. Elected Dean of the law faculty of Notre Dame University in 1883. Subjects taught cover practically the entire law school course.

**HOYT, Lucius W., Dean of the University of Denver Law School.**—Born in Hartford, Mich., December 31, 1860. Son of Benjamin F. Hoyt and Frances E. Hoyt. Educated at the Michigan Agricultural College and Columbia University, receiving the degree of LL. B. from the latter in 1889. Married Catharine C. Potter on August 27, 1889. Admitted to the Bar of Michigan in 1889, of Illinois in 1889, and of Colorado in 1890. Professor of Law in the University of Denver from 1893 to date. Secretary of the law faculty of that school from 1892 to 1902, and Dean of the same since 1902. Subjects taught: "Mining Law," "Negotiable Paper," "Private and Public Corporations," and "Sales." Author of the Article on "Lost Instruments" in *Cyclopedia of Law and Procedure*.

**HUBERICH, Charles H., Acting Dean of the Leland Stanford, Jr., University Law School.**—Born in Toledo, Ohio, February 18, 1877. Son of Conrad Huberich and Emma Rechas Huberich. Received the degree of LL. B. from the University of Texas in 1897, and that of LL. M. from the same University in 1898. In 1899 the degree of D. C. L. was conferred upon him by Yale University. From 1899 to 1900 studied in Berlin and Heidelberg Universities, receiving from the latter the degree of J. U. D. (*magna cum laude*). In 1907 the honorary degree of LL. D. was conferred on him by the University of Melbourne, Australia. Married Laura Orr, of Austin, Texas, in 1902. Admitted to the bar of Texas in 1898. Professor of Law in the University of Texas, 1900 to 1905. Professor of Law and Acting Dean of Stanford University Law School since 1906. Subjects taught: "Constitutional Law," "Criminal Law and Procedure," and "Conflict of Laws." Author of numerous articles on legal subjects. Now engaged in preparing work on "Commercial Law of Aus-
