

(1.5 Law Practice Management) "Proportionality" is the new buzzword in eDiscovery since amendments to the Federal Rules of Civil Procedure went into effect on December 1, 2015. This panel will explore what it means for eDiscovery to be "proportionate," and will offer practical tips and strategies that parties can implement immediately to achieve the just, speedy, and inexpensive resolution of their disputes in state and federal courts. Alternatives to be explored include: cooperation and meet-and-confer strategies; phased discovery; the use of technology-assisted review ("TAR") and other advanced search tools; claw-back agreements and Rule 502(d) orders; and categorical privilege logs. This panel of well-known judges and practitioners, who are experienced in eDiscovery matters, will offer their perspectives on controlling the burgeoning costs of eDiscovery.

The Farmers' Museum
