THE COLLEGE OF LAW

REGISTRATION: It is gratifying to note that the registration in the College of Law in September, 1931, is six more than in September, 1930. Considering the times and the fact that admission requirements to the College of Law were raised to three years of College work, this augurs for a marked increase in attendance in the future. The number registered in the different groups is as follows: First year 85; Second year 34; Third year 27, and special students 4, or a total of 150.

FACULTY: There have been no changes in the full-time members of the faculty. The full-time members are Professors Thomas F. Konop, dean, Clarence E. Manion, Elton E. Richter, Homer Q. Earl, William D. Rollison and William M. Cain.

THE LAW LIBRARY: The President of the University has authorized a special appropriation of \$2600.00 to complete the reports of the courts of last resort of every state in the United States. Statutes of many states and new treatises are also being added to the library. The library of the College of Law ranks with the best in the country.

THE LAW CLUB: Last year under the auspices of the Law Club, eight lectures were delivered to the students in the College of Law. Among the lecturers were Hon. Richard W. Ruffin, Justice of the Supreme Court of Mexico and Hon. Edward J. Dempsey, a member of the Board of Law Examiners of Wisconsin. Justice Ruffin gave a very interesting and instructive lecture on the administration of justice in Mexico. Mr. Dempsey discussed bar examinations. One of the interesting programs last year was a dinner given by the law club to the Executive Committee of the Indiana State Bar Association. Every member of the committee spoke. The late Mr. W. Miller of Gary, the then president of the Indiana State Bar Association, was also present and in his usual interesting way spoke words of encouragement to students as well as to young practitioners. The members of the Notre Dame law club will miss him.

Edward J. England, a senior in the College of Law, is president of the Law Club for the year 1931-1932. In co-operation with the dean, arrangements are being made for lecturers and programs are being planned for the year. The first dinner of the club was held on Thursday, November 5th.
