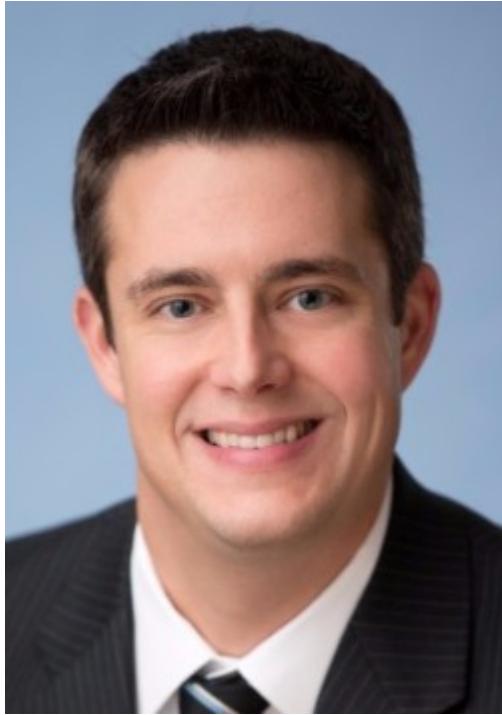


Congratulations to LL.M. Students in the International Human Rights Program Who Won the Price Media Moot Court Competition
