We are celebrating the 50th anniversary of the Notre Dame London Law Program, and we want you to join us in London for the Golden Jubilee.

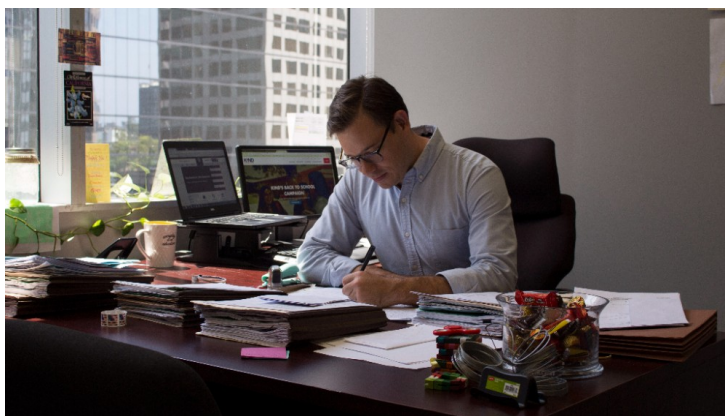

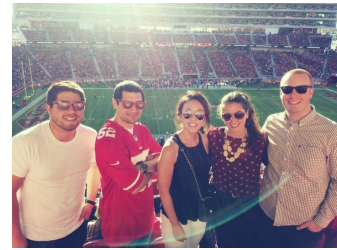
