On Wednesday, **April 19**, rising 3L students and LLM students (including London, Exchange program and Chicago program students for fall semester) from 12:30 – 12:40 pm will register for up to 9 credits. Then from 5:00 pm to

11:59 pm they will register for the remaining credits up to 18 maximum.

On Thursday, **April 20**, rising 2L students (including London, Exchange program and Chicago program students for fall semester) from 12:30 pm - 12:40 pm will register for up to 9 credits. Then from 5:00 pm to 11:59 pm they will register for the remaining credits up to 18 maximum.

On Friday, **April 21** the system will open for all law students to drop/add courses beginning at 1:00 pm through August 25 ending at 5:00 pm. Note well the professor-set deadline for adding and dropping intensive courses which being prior to the regular start of the semester.


Saturday - April 22nd
