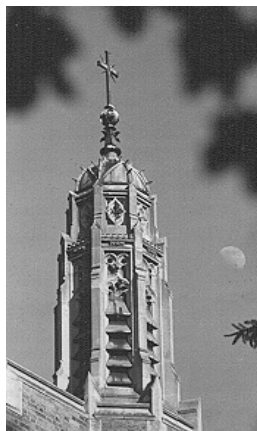

### Stephen Smith Tackles Religious Freedom in New Book

Stephen Smith, Robert and Marion Short Professor of Law at NDLS, has published *GETTING OVER EQUALITY: A CRITICAL DIAGNOSIS OF RELIGIOUS FREEDOM IN AMERICA* (New York University Press). According to a review in the December 1, 2001, issue of *First Things: A Monthly Journal of Religion and Public Life*, the book "[moves] beyond stale arguments about the 'separation of church and state' and expos[es] the incoherence of doctrines of 'equality.'" In his book, Steve "proposes a vibrant practice of tolerance and prudence that holds high promise for our continuing debate over the role of religion in the public square. His argument is lucid, forceful, sometimes eccentric, and refreshingly free of legalistic cant."

### New Classes for Spring Semester Focus on Criminal Justice

Donald Schmid '82, Assistant U.S. Attorney and for the Northern District of Indiana, Ian Axford Fellow in Public Policy with the U.S. Department of Justice and a new adjunct assistant professor of law at NDLS, will offer a course on "Restorative Justice: A New Paradigm in Criminal Justice Policy" in the spring 2002 semester. The two-credit course will survey criminal-justice policy in the 19<sup>th</sup> and 20<sup>th</sup> centuries, then address the advent in the 1990s of restorative

justice as a new paradigm in criminal-justice policy. As Don explains, "Restorative justice has been hailed for giving crime victims a powerful voice, for rebuilding communities, for emphasizing offender accountability and for more effectively reintegrating offenders into society." The course will also examine restorative-justice programs around the world in countries such as New Zealand, Australia and Canada, as well as across Europe and in the U.S.

Douglas Cassel, a visiting scholar in the Center for Civil & Human Rights, director of the Center for International Human Rights and Associate Professor of Law at Northwestern University Law School, will teach a course on "International Criminal Justice" in the spring 2002 semester. The course will review the current international-law standards on what constitute war crimes and crimes against humanity, and the emerging principles that create an affirmative obligation to punish such crimes. The course will include a survey of attempts by the international community to put an end to the cycle of impunity that frequently surrounds mass atrocities. The course also includes an in-depth view of the procedures applied and the jurisprudence generated by the International Criminal Tribunals for the Former Yugoslavia and for Rwanda, as well as an analysis of their most important cases. The course will also address the 1998 Rome Statute for an International Criminal Court and the U.S. position on the ICC. It also includes a discussion of the renewed possibility of extra-territorial prosecution under the principles of universal jurisdiction, particularly after the decision of the British Law Lords in *Ex Parte Pinochet*. The course will also cover jurisdictional and procedural issues, especially with regard to the fair-trial rights of defendants and to the protection of victims and witnesses.

#### Faculty Notes

Bob Blakey represented Canada in a suit against R.J. Reynolds Tobacco Company in the U.S. Court of Appeals for the Second Circuit. The case involved RICO charges brought by the attorney general of Canada against a number of U.S. tobacco manufacturers, alleging that the companies smuggled cigarettes into Canada to avoid paying taxes. The court voted 2-1 to dismiss the case, however, citing a centuries-old, common-law principle that bars foreign governments from using American courts to enforce foreign tax laws. Michael Gurdak '84, '87J.D., of the Washington, D.C., office of Jones, Day, Reavis & Pogue, represented R.J. Reynolds in the case. The text of the opinion can be found at No. 00-7972 (2d Cir., Oct. 12, 2001).

In an article titled *Circuit Revives RICO Claims in Hiring Aliens* in the November 26, 2001, edition of the NEW YORK LAW JOURNAL, Bob commented on a decision by the Second Circuit to reinstate a RICO case between two cleaning companies over the alleged illegal hiring of undocumented workers. One cleaning company alleged that a competitor engaged in a pattern of hiring undocumented workers to reduce its costs and thereby helping it to underbid competitors, including the plaintiff. The district court found that the plaintiff did not have standing to sue because it did not demonstrate proximate harm. Commenting on the appellate court's decision to reinstate the case, Bob noted that the decision was significant because the court has "now told people who are competitively injured by the abuse of the immigration system that they have a remedy under RICO." Courts have been hostile to such competitive-injury claims in the past, but in 1996 Congress expanded RICO to include immigration-related crimes.

Rick Garnett published *A Quiet Faith? Taxes, Politics, and the Privatization of Religion* in volume 42 of the BOSTON COLLEGE LAW REVIEW. He also co-authored an *amicus* brief on behalf of the Becket Fund for Religious Liberty in *Zelman v. Simmons-Harris*, a school-choice case currently before the United States Supreme Court.

John Nagle led a discussion on the current national debate regarding the regulation of arsenic in drinking water at a meeting of the NDLS Environmental Law Society on November 14.

Garth Meintjes and Jay Tidmarsh participated in a discussion on "Civil and Human Rights" as part of the "Week of Peace and War Education" sponsored by the University in mid-November.

Bob Rodes gave a colloquium on "Medieval English Secular Legal Materials" to the University's Medieval Institute on October 16, 2001.

Tom Shaffer published *The Radical Reformation and the Jurisprudence of Forgiveness* in CHRISTIAN PERSPECTIVES ON LEGAL THOUGHT, edited by Michael W. McConnell, Robert F. Cochran Jr. and Angela C. Carmella (Yale University Press 2001).

Barbara Szveda spoke on current judicial decisions in asylum cases at the Asylum Conference sponsored by the American Immigration Lawyers Association in Chicago on October 19-20.

Jay Tidmarsh gave the inaugural presentation to the NDLS chapter of the American Constitution Society, "'Originalism' and the United States Constitution: A Response" on November 20.

Mr. Gagnon served as a Lieutenant in the U.S. Navy and as Captain of a PT boat in World War II in the South Pacific.
