As the fall semester winds down, we'd like to take a moment to thank the three outstanding professors who visited NDLS this semester. They enriched us with their energy, erudition, and enthusiasm.

Visiting Professor **Barry Cushman** is James Monroe Distinguished

 Professor of Law and Professor of History at the University of Virginia. Professor Cushman returned to Virginia in 1998 from the faculty of the St. Louis University School of Law, where he received the Thompson Coburn Faculty Scholarship Award and was twice voted Student Bar Association Teacher of the Year. Before entering law teaching he clerked for Judge Richard F. Neely of the West Virginia Supreme Court of Appeals and practiced law with Riordan & McKinzie in Los Angeles. In 1990-91 he was the Samuel I. Golieb Fellow in Legal History at New York University School of Law. His book, *Rethinking the New Deal Court: The Structure of a Constitutional Revolution* (Oxford University Press), was awarded the American Historical Association's 1998 Littleton-Griswold Prize in American Law and Society. In 2003, he was honored with the University of Virginia's All-University Teaching Award. Professor Cushman received his B.A. from Amherst College, his M.A. and Ph.D. from the University of Virginia, and his J.D. from the University of Virginia School of Law.

Matwysbyn is Assistant Professor of Legal

Studies and Business Ethics at the Wharton School of the University of Pennsylvania. Dr. Matwysbyn is a leading authority on commercial privacy law, corporate information security regulation, and technology law. Prior to joining the University of Pennsylvania faculty, she taught on the law faculties of Northwestern University and University of Florida. Before she started teaching, she was a corporate/technology transactions attorney in private practice, counseling both Fortune 500 and start-up clients on technology law and information privacy and security questions. During the summer of 2011 she was a visiting scholar at the Oxford Internet Institute. Dr. Matwysbyn received her J.D. with Honors in 1999 from Northwestern University School of Law. She also received her B.A. with Honors in Political Science/International Studies, her M.A. in International Relations, and her Ph.D. in Human Development and Social Policy from Northwestern University.

of Law at Chicago-Kent College of Law, where he teaches patent law, patent litigation and intellectual property strategies classes. He joined the Chicago-Kent faculty in 2009 after teaching for three years at The John Marshall Law School in Chicago. From 2000 to 2006, he was a partner at two intellectual property boutique firms in Chicago, where his practice included patent, copyright, trademark and trade secrets litigation; patent and trademark prosecution; and intellectual property-related transactions. He began his career in intellectual property law in 1995 as an associate at Jenner & Block. In 1995, Professor Schwartz graduated cum laude from the University of Michigan Law School after earning a B.S. degree with high distinction in chemical engineering from the University of Illinois at Urbana-Champaign.
