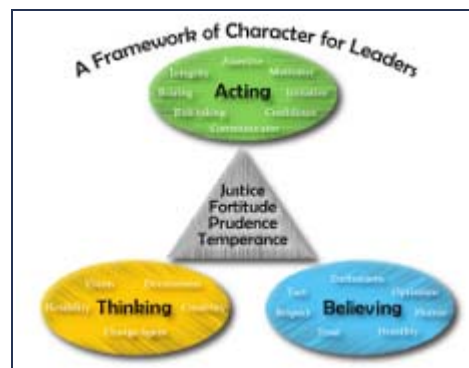

On Thursday, January 31 at 4:00 p.m. in Room 3140 is the **Constitutional Structure Lecture** by Dieter Grimm. **Dieter Grimm** is Professor of Law at Humboldt University of Berlin and a Permanent Fellow and former Director of the Wissenschaftskolleg zu Berlin Institute for Advanced Study. From 1987 until 1999, he served as a Justice on the Federal Constitutional Court of Germany. An honorary member of the American Academy of Arts and Sciences, he holds law degrees from the University of Frankfurt and a Master of Laws from Harvard. The subject of his talk will be “Dignity and Freedom of Speech: An American-German Comparison.”

CCHR is hosting Visiting Speaker **Dr. Seyed Masoud Noori** on Friday, February 1 at 12:30 p.m. in Room 1140. One of most important and challenging debates in Muslim world, from North Africa to the Middle East and South Asia is the relation between “*Shariah*” and “State Law.” Beginning with a review of the concept of “*Shariah*,” its bases and sources, as well as “*Ijtihad*,” the method of understanding Shariah, Dr. Noori focuses on “*Justice-Based Ijtihad*” as a bridge between “*Shariah*” and “*Human Rights*” and examines the results of this theoretical debate on the 2012 Constitution of Egypt. Seyed Masoud Noori is a former Faculty member of Department of Law, Mofid University (Qom, Iran), a Member of Academic Council of the Center for Human Rights Studies (CHRS) and a member of Council Law Clinic at that university. He has served as Deputy Director and Director of Research and Education for the Center. This talk is



co-sponsored by the Kellogg Institute for International Studies.

From the Library

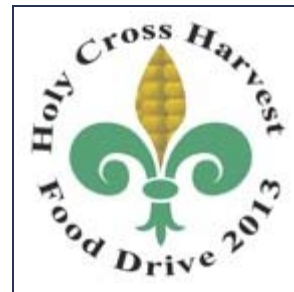
