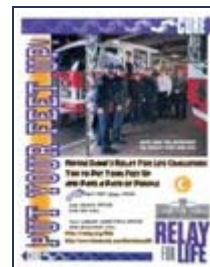


Congratulations to **Sandra Klein**, who celebrates her 15-year service anniversary with the law library this March!
