# Ralph Nader Visits NDLS

Consumer advocate Ralph Nader delivered a lecture entitled "Legislating Corporate Ethics" on March 26, 2003. A reception for law school faculty and students followed in the student lounge where Mr. Nader greeted the law school community and autographed books for well wishers. Mr. Nader has played a central role in numerous consumer issues. He and the organizations he has founded have been responsible for eight major federal consumer protection laws, including the Safe Drinking Water Act; the creation of federal regulatory agencies such as the Occupational Safety and Health Administration, Environmental Protection Agency and Consumer Product Safety Administration; and greater access to government through the passage of the Freedom of Information Act in 1974. Nader, who was the Green Party candidate for President in 2000, earned his bachelor's degree

from Princeton in 1955 and his law degree from Harvard in 1958.

The Thomas J. White Center on Law & Government and the Journal of Law, Ethics & Public Policy sponsor two symposia each year on topics that correspond to each journal issue. The first of the two events "Bioethics: Can Regulations 'Stem' Scientific Progress?" was held March 24, 2003. Speakers engaged in an in-depth analysis of the federal government's attempts to stop human cloning and embryonic stem cell research. Participants included Clarke D. Forsythe, President, Americans United for Life; Dr. Nathan A. Adams, IV, Chief Litigation Counsel for the Christian Legal Society; and Dr. Maureen Condic, Assistant Professor of Neurobiology and Anatomy, University of Utah. Moderator for the event was Associate Dean John Robinson.

The second event "Religion in Public Schools?: Debating Creation, Evolution, and

Intelligent Design" was held April 15, 2003. Speakers for this event included, NDLS Professor Gerry Bradley; Professor Kent Greenawalt, Columbia Law School; and Associate Professor Steven Green, Willamette University College of Law and Special Counsel, Americans United for Separation of Church and State. Moderator for the event was Associate Professor Rick Garnett.

#### Natural Law Institute Conference

Several of the world's leading philosophers were on campus April 10-11, 2003 to discuss the question "Law's Moral Foundations: Has it Any?" during a conference sponsored by the Natural Law Institute. The conference opened with a keynote address by Joseph Raz, Philosophy of Law Professor, University of Oxford and Fellow of Balliol College, Oxford. Other speakers included Jude Chua Soo-Meng, National University of Singapore and Center for Philosophy of Religion at Notre Dame; Timothy Endicott, Fellow in Law at Balliol College, University of Oxford; M.H. Kramer, Professor of Legal and Political Philosophy, University of Cambridge; and Brian Leiter, Joseph D. Jamail Centennial Chair in Law, University of Texas. The conference concluded with the annual Natural Law Lecture, this year given by John M. Finnis.

Matthew Barrett gave a presentation entitled "Enron, Accounting, and Lawyers (After the recent scandals and the Sarbanes-Oxley Act of 2002)" during the Sorin Society Recognition Weekend on March 1, 2003. He was also inducted into the Notre Dame chapter of Phi Beta Kappa as an alumnus member on April 1, 2003.

Joseph P. Bauer published Volume II of Kintner's <u>Federal Antitrust Law</u> treatise, with William H. Page (Anderson Publishing, 2002). The subject of this volume: *Practices Prohibited by the Sherman Act*.

Lisa Casey gave a presentation to attorneys at Barnes & Thornburg on March 3 entitled, "The SEC's New Regulations for Lawyers Representing Public Companies."

Father Malloy re-appointed Tex Dutile, NDLS '65, to a three-year term as Chair of Notre Dame's Faculty Board on Athletics and as the University's NCAA Faculty Athletics Representative.

On March 1, Tex delivered a talk entitled, "The Problems and Challenges of Intercollegiate Athletics," at a luncheon forming part of the Alumni Association's "Florida Fling," in Palm Beach, Florida. The "Florida Fling" is an annual spring reunion for Notre Dame alumni who received their degrees at least fifty years ago and for alums of all ages who live in Florida. Father Hesburgh was the Fling's dinner speaker.

On March 7, Tex spoke at a UND-night dinner sponsored by the Notre Dame Club of Kokomo, Indiana. Tex also delivered a UND-night talk to the Notre Dame Club of New Hampshire, on April 12, at Rivier College, Nashua, New Hampshire. The topic both nights: "Academics and Athletics at Notre Dame."

Barbara Fick published, *Musical Courts: Plaintiff Picks a Court but Can Defendant Trump the Choice? An Analysis of Breuer v. Jim's Concrete of Brevard, 6 Preview of United States Supreme Court Cases 338 (March 21, 2003).* 

Rick Garnett presented a paper, "The Blaine Amendments and the Purpose of Education," at a conference sponsored by the Pew Forum on Religion and Public Life and The First Amendment Law Review, at the University of North Carolina School of Law, on March 28, 2003. He presented a talk to the St. Thomas More Society, on April 2, on the recent "Doctrinal Note on Some Questions Regarding the Participation of Catholics in Political Life." On April 10-12, he served as the invited commentator at a conference sponsored by the Brookings Institute and held in London, on "Regulating Choice to Promote Civic Values: What Can the U.S. Learn from the Experience of Other Nations?"

Jimmy Gurulé was recently honored for his service as Under Secretary of the Treasury for Enforcement with the Treasury Medal by John W. Snow, Secretary of the Treasury. He traveled to London the week of April 14th for a week of speaking engagements. He spoke at an anti-money-laundering conference sponsored by the Central Banking Publications of senior central bank regulators. He also spoke at a roundtable sponsored by the Centre for the Study of Financial Innovation, an independent think-tank based in London, formed to stimulate research into the future of the financial services industry, and to provide a neutral meeting ground for financial practitioners to share ideas. He lectured before the British Institute on International and Comparative Law on terrorist financing. Finally, he spoke at the Notre Dame Law Centre on "Unfunding Terror: The Financial War Against Al Qaeda."

Cathy Kaveny was elected to the editorial board of the Journal of Religious Ethics.

William P. Hoye presented "Bringing Legal Ethics Back into Corporate Governance" at the ACLI Insurance and Law Seminar, February 4, 2003.

Roger F. Jacobs was asked to consult with the University of Dayton Law School on law library staffing and collection development issues. He recently accompanied Dean O'Hara, Associate Dean Jack Pratt, and Law School administrator Cathy Roemer, to the ABA conference on law school architecture held at Suffolk Law School in Boston, March 19-22, 2003. Visits to view the Harvard and Boston College library renovations were included in the program.

He also facilitated a discussion on Legal Issues Confronting Private Colleges and Universities at the 24<sup>th</sup> Annual National Conference on Law and Higher Education, sponsored by Stetson University College of Law, February 16-18, 2003.

Dinah Shelton, At the annual meeting of the American Society of International Law, April 2-6, 2003, Dinah Shelton was elected to one of the Society's highest offices, Counselor of the Society. She also was one of five persons elected to the Board of Editors of the American Journal of International Law, the premier scholarly publication in the field. Last month, Professor Shelton was among a group of experts who conducted a training seminar for the United Nations Institute for Training and Research in Kushiro, Japan. The session addressed issues of protecting marine living resources and was addressed to government officials from the Asia-Pacific region. Following the Kushiro Workshop, Professor Shelton delivered a paper at a conference on international and domestic legal responses to September 11. The conference was sponsored by and held at the University of Sussex, England. In January, Professor Shelton was sent by the U.S. State Department to assist universities in Ecuador develop teaching materials for courses in human rights.

Eric Smithburn co-authored with Ann-Carol Nash, Family Law - Children in Need of Services (West Group 2003). This is the third volume in the Indiana Family Law series. He lectured on a variety of evidence topics at a program entitled, "Evidence in Juvenile and Family Court," at the University of Nevada, Reno, NV, September 2002. Barbara also traveled to Havana, Cuba, speaking to Catholic Church about human rights and the Catholic Church's involvement with the Cuban government. Her travels were a part of a class that she is teaching in the Theology Department, "From Power to Communion", she was accompanied by NDLS students Shannon Benbow, Julissa Robles, Sairah Saeed and Rebecca McCurdy.

#### News From The Law Library

The Kresge Law library recently acquired cataloging records for some 85,000 microform titles and added these records to its electronic catalog, LINK. These titles, previously available only through print indexes, increased the total number of both print and non-print titles accessible through LINK to 190,000 titles ranking 36th among 187 law libraries nationally.

Colin J. Reilly, '98 has become a partner with Jones Obenchain, LLP in South Bend.


