## **SPORT REPORT**

This week's Sport Report comes from 3L Justin North who was kind enough to help me out! Thank you Justin for keeping us up-to-date in the wide world of sports!

Another great sports weekend is in the books, although compared with last weekend we had to look a bit harder for competitive college football, but nonetheless, here are a few highlights from this weekend:

College Football:

- The top 8 teams each won by more than 3 TD, so no summary necessary other than Go Irish!
- Florida lost their QB (Franks), but still avoided the upset at Kentucky 29-21
- Central Florida, the highest ranked "non-power 5" team won a statement game against Stanford 45-27
- Arizona State won the ugliest game of the year against Michigan State, in East Lansing, 10-7
- Iowa survived Iowa State due to a muffed punt in the waning seconds of the game, 18-17
- BYU upset USC in overtime 30-27

College Football Takeaway: Notre Dame needs to go undefeated to make the playoffs because their annual "big games" against Stanford and USC are not likely going to be "big" this year (see above), and after last week, Michigan isn't looking so great either. Needless to say, the season will be shaped, in large part, by what happens in Athens next Saturday.

## NFL Football:

- On Thursday, the Buccaneers beat the Panthers 20-14 on the strength of a goal-line stand with less than two minutes to play
- In a battle of 2 of the last 3 Heisman Trophy Winners (Lamar Jackson and Kyler Murray), Baltimore improved to 2-0 and the Cardinals fell to 0-1-1 in a 23-17 Ravens victory
- Cowboys improved to 2-0 by beating rival Redskins 31-21 in Washington
- The Bills also moved to a surprising 2-0 by beating the woeful Giants 28-14
- The Patriots dominated the jaw-droppingly awful Dolphins 43-0
- The Packers are also 2-0 after beating division rival Minnesota 21-16

NFL Takeaway: The Patriots look very good again (even if Antonio Brown gets suspended for his alleged #MeToo problem) and the Dolphins are historically bad. Aside from that, there is great parity in the league and it is far too early in the season to celebrate or panic too much.

## MLB Update:

- Dodgers and Braves have clinched playoff spots
- Yankees, Astros, Twins, and Cardinals are in first place in their respective divisions and each have above a 90% chance to make the playoffs at this point
- If the season ended today, the As and Rays would be your AL wild-card teams while the Nationals and Cubs would be the NL wild-card opponents. However, Cleveland is only 2 games back of the last AL slot and in the NL, the Brewers, Mets, Phillies, and Diamondbacks are all within 5 games with less than 15 games to go in the season

MLB Takeaway: This season continues to be an odd one, with 3 historically good teams (Dodgers, Yankees, Astros all likely to win 104+ games) and 4 historically bad teams (Tigers and Orioles have already lost 100 games, and the Royals and Marlins will join them in that ignominious club before the end of the season). Also, we have seen a historic number of homeruns this season, the record was set in 2017 with 6,105 and there have ALREADY been 6,213 in 2019. All that goes to show that the post-season is going to be thrilling!

This week's professor is Nicole Garnett. She loves to cook, her passion is education law, and she's from Kansas City! Thank you Professor Garnett for participating in our spotlight!

### Legal work prior to joining the faculty

- Law clerk to Morris S. Arnold (8th Circuit) and Justice Clarence Thomas
- Fun fact: Dean Marcus Cole clerked for Judge Arnold and interviewed me for my clerkship in 1993. We've been friends ever since. If you'd like to see a picture of Judge Arnold holding two of his favorite "grandclerks" (Claude Cole and Maggie Garnett) in 2000, stop by my office. They are both sophomores in college now.
- I was a staff attorney for two years at the Institute for Justice in Washington, D.C. I was part of the legal team that helped defend the Cleveland Pilot Scholarship Program against an Establishment Clause challenge. The US Supreme Court rejected the challenge in *Zelman v. Simmons Harris*, two years after I joined the faculty.

### Classes you teach/have taught or areas of study you are particularly interested in

- Property, Education Law, Local Government Law, State Constitutional Law, and (previously) Urban Development and the Law of Higher Education
- My research has focused on land use/urban development issues and education policy. I'm most proud of the book that I co-authored with Prof. Peg Brinig in 2014, *Lost Classroom, Lost Community: Catholic Schools' Importance in Urban America*. The book brings urban development and education policy together by demonstrating that urban neighborhoods become more dangerous, more disorderly and less socially cohesive when Catholic schools close.
- At Notre Dame, I'm very involved with the work of the Alliance for Catholic Education, which supports in a variety of ways K12 Catholic schools serving disadvantaged students.



### Any current research you are conducting or projects you are working on?

- I've been writing about educational accountability and parental choice policies at home and abroad.

I'm part of an interdisciplinary research team at Notre Dame that is studying Catholic schools in developing nations.

What is your favorite hobby outside of the law school?

- My favorite hobby is cooking. I also love entertaining friends and spending time with my family. We have four kids. Maggie is a sophomore at ND, Tommy is a senior in HS, Libby is a sophomore and Johnny is in first grade.

Favorite college sports team?

- Kansas Jayhawks. (If you don't know that I'm from Kansas City, then you haven't met me. If you are from Kansas City, come say hi.)

- Crooked Ewe and Crooked Ewe

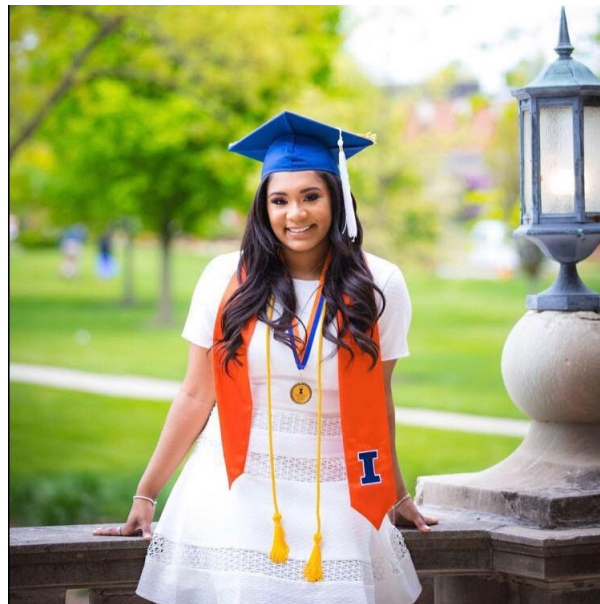
If you could tell your law school self one thing, what would it be?
