---A third prize will be awarded to the lady or gentleman who raises the most money for the Women's Care Center.

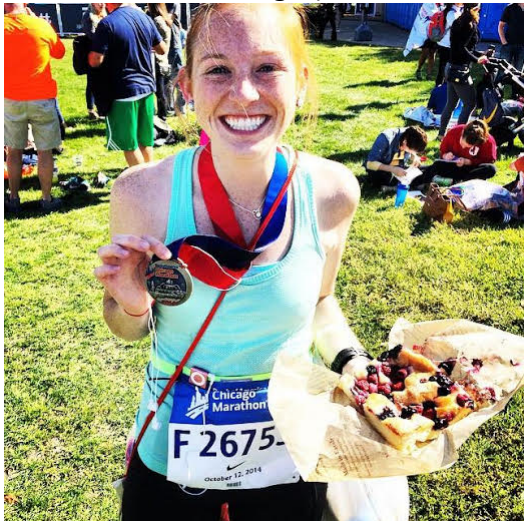
