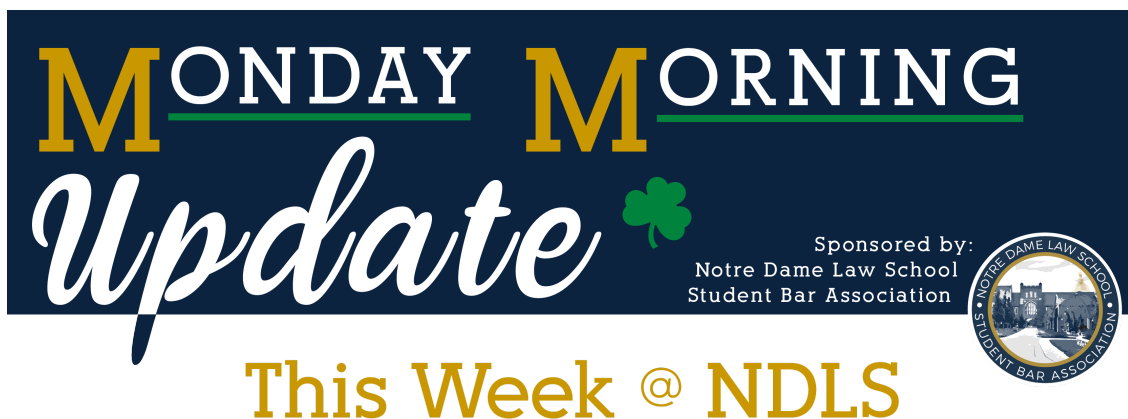

The Klau Center for Civil and Human Rights sponsors summer fellowships for work in public interest organizations that promote civil or human rights, and/or the enforcement of federal rights on behalf of underrepresented minorities.
