Jimmy Gurule filed an amicus brief in the United States Court of Appeals for the District of Columbia in support of appellants in *Peterson, et al. v. Islamic Republic of Iran, et al.* The amicus brief was filed on behalf of Members of Congress for the Enforcement of Terrorism Judgments from Blocked Assets of State-Sponsors of Terrorism. Appellants obtained a judgment of over \$2 billion against Iran for aiding and abetting the 1983 terrorist attack against the U.S. Marine barracks in Beirut, Lebanon, and are seeking to enforce the judgment against blocked assets of Iran held in the U.S. by HSBC.
