

A Message From the Editor ~Secretary~

Good Morning NDLS!

In making the <u>Instagram-famous pasta</u> this weekend that supposedly left Finland sans feta cheese for a while, I realized several things. One—people need to eat more vegetables and learn how to season. I guess that's two things, but still. I rarely follow recipes so it wasn't until I was eating the final (and excellent if I do say so myself) product, comparing it in my head to the original that I realized how different the flavor and nutrients probably were. The recipe originally calls for only cherry tomatoes (not technically a vegetable), basil (an herb), garlic (botanically a vegetable but arguably a spice), and feta (cheese) and is advertised as a main dish. Where are the veggies and protein outside the feta cheese I ask you? Also, how was it only supposed to be seasoned with salt and pepper? You will not find a bigger supporter of salt and pepper than me, but flavor is the spice of life and people deserve more, especially when the dish is so creamy. My spice collection has been years in the making and, if I should be so bold, a friend in my life (shoutout to Fiesta brand's Texas Steak Seasoning that's great on so much more than steak). We added onions, mushrooms, asparagus, and spinach, used Italian herb seasoning and red chili flakes to cut through the feta, and paired the dish with skillet-grilled rabbit and bacon-wrapped dove. Now that was a meal.

Two—it's been a hot minute since I cooked a meal. Since two weeks before school started I think. I think that might be the longest I've gone without cooking since I moved to college seven years ago. I took an AR position this semester, and for the first time in my higher education career, I have a campus dining pass. Going to A&M, there was not enough dorm space on campus for all of the freshman, much less any other upperclassman. As a result, living on campus was not required, and I did not volunteer as tribute. I had two desires that made dorm life unappealing. (Yes, there were also several economic factors that also supported living off-campus in a trailer park, but they are irrelevant to my point here). First, I had absolutely no interest in sharing a single room with a stranger. That sounded like a very good way to get murdered or framed for murder to me. Second, I could not fathom not having my own kitchen. I grew up in a household that cooked a lot, harvested a notable portion of our food between gardening and hunting, and had no intention of giving that up. I was sure intermittent trips home and poaching veggies and meat from my parents was both better for me and more fiscally responsible. I stand by that but have now entered the brave new world of campus dining.

Three—upon entering this world, I now understand so much more. The seeming obsession of undergrads with "home cooked meals"? Makes total sense to me now. One bite into my pasta and dove and I realized what all I've been missing. Do not misunderstand, Campus Dining is good and offers an impressive variety. A fresh, experimenting experience seasoned for explosive flavor, however, it is not. The "freshman fifteen"? Also makes sense to me now. They just let you eat as much as

you want of whatever you want with one swipe. There's none of that, "These chicken fajitas cost me \$15, aka two of my 15 hours of student worker pay, so they need to last me 3-4 meals." You just swipe and get as much as you want. The food-to-money value relationship is nonexistent. As someone who has been trying to maximize my access to free food for seven years (RIP law school lunch presentations), it is crazy pants. Portion control is v important. What has helped~hurt me deeply~has been the coronavirus' impact on the unlimited ice cream bar. The skeleton of the once glorious station remains, but no ice cream is served. No floats are made. It's a sad time, ergo the pasta comfort food endeavor.
