News and Notes

Happy Constitution Day! On this date in 1787, delegates to the Constitutional Convention in Philadelphia signed the U.S. Constitution.

Tonight, **Rick Garnett** will be giving the Hesburgh Lecture at The University of Illinois Springfield Engaged Citizenship Common Experience (ECCE) Speakers Series and the Notre Dame Club of Central Illinois presents "Law, Religion, and Politics in the American Constitution and Tradition" as part of a Constitution Day event.

Prof. Michael Zuckert is lecturing on ["Slavery and the Constitution: An immoral compromise?"](#) at the Walter Berns Constitution Day Lecture.

On September 12, **Jimmy Gurulé** returned from Seoul, South Korea, where he spoke at the Second International Counter-Terrorism Conference sponsored in part by the Korean National Police Agency. The conference was attended by senior government officials from South Korea, the Philippines, and Singapore. There were over 1,000 conference participants. His address was entitled: "Collecting Foreign Intelligence Information under the U.S. Foreign Intelligence Surveillance Act: Legal Issues and Challenges." After his presentation, he was invited to participate in a series of meetings with senior Korean government officials at the Korean National Police Academy, Korean National Police University, Cyber Terror Response Center, Seoul Municipal Police Emergency Response Center, the Unit 868 – Seoul SWAT Center, and SMPA Riot Police Headquarters.
