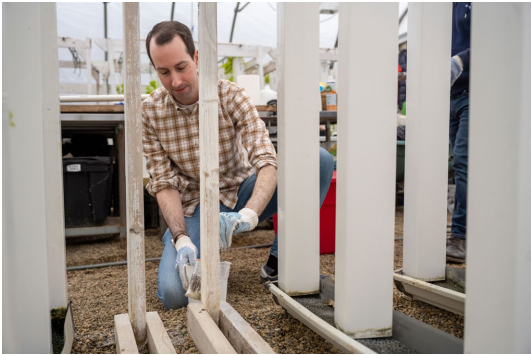
Notre Dame Law School serves community on 2023 Martin Luther King Jr. Day of Service

DEI Podcast: Advocating for the Innocent: Exoneration Justice

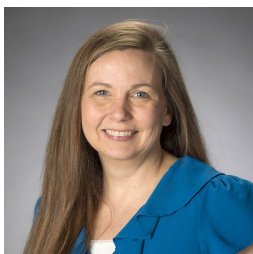

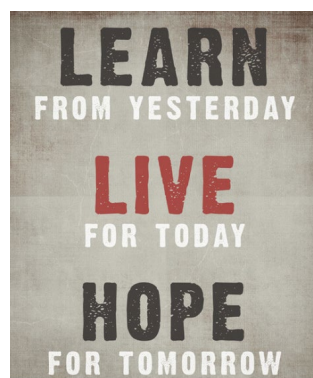
