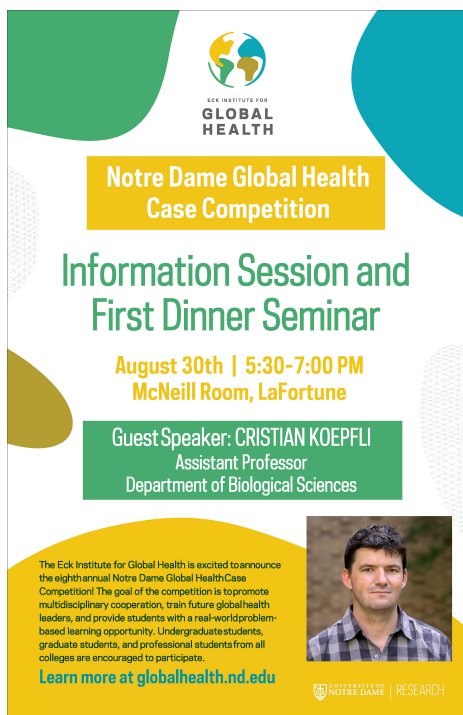

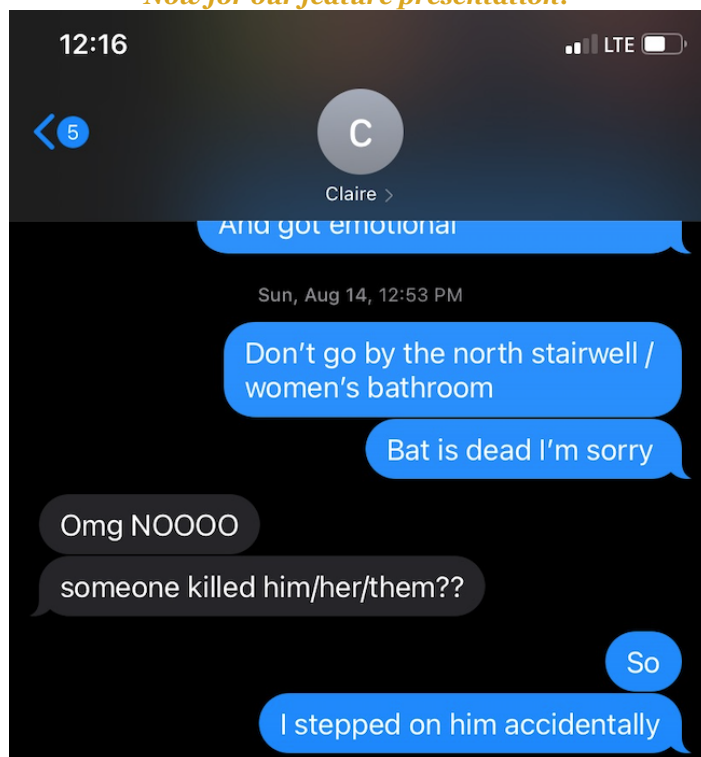
Q. Who should be the next 1L of the week?
