



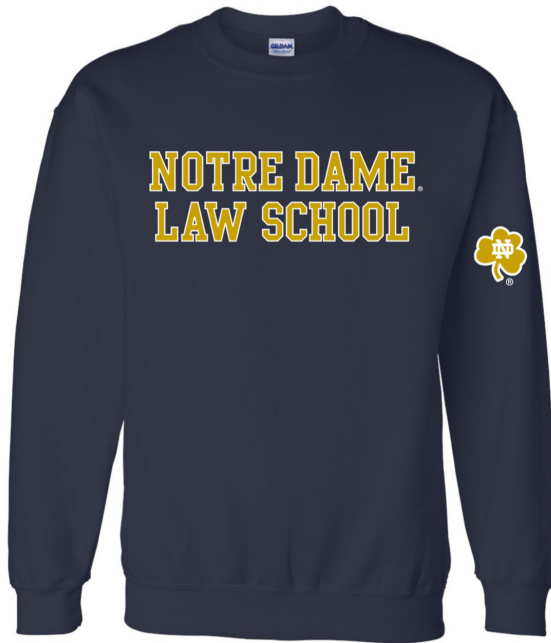

You're going to realize not everyone outlines. Not everyone studies the same. This is the most important moment to NOT compare yourself to others.

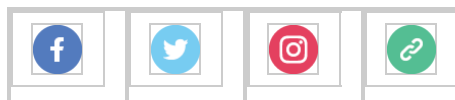
