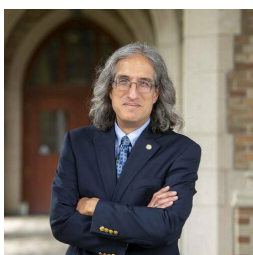

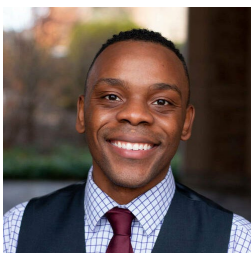


**Rick Garnett and Sherif Girgis** participated in a interdisciplinary workshop on law, religion, and equality last week at the University of Oxford.
