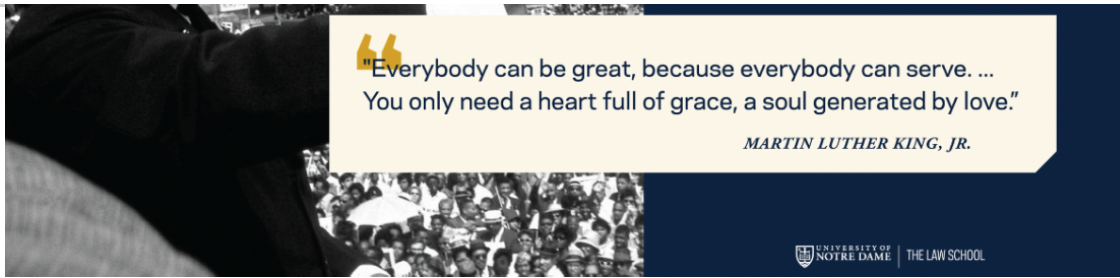

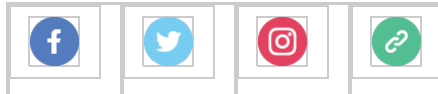
### **Financial Wellness Week: January 23-27**
