## 2023 Notre Dame Religious Liberty Summit Protecting Religious Liberty in a Rapidly Evolving Society

The Notre Dame Law School Religious Liberty Initiative held its 3rd Annual Notre Dame Religious Liberty Summit on July 10-13 in London. The Honourable Society of the Inner Temple hosted academic programming for the summit with panelists and keynote speakers discussing many of the challenges facing the freedom of religion or belief today.

Evening programming included Mass at Notre Dame de France, a dinner boat cruise on the River Thames, a tour of Westminster Abbey, and receptions at Notre Dame's London Gateway and the UK Supreme Court.

The Summit culminated with a black-tie gala at the Merchant Taylors' Hall in London. 
