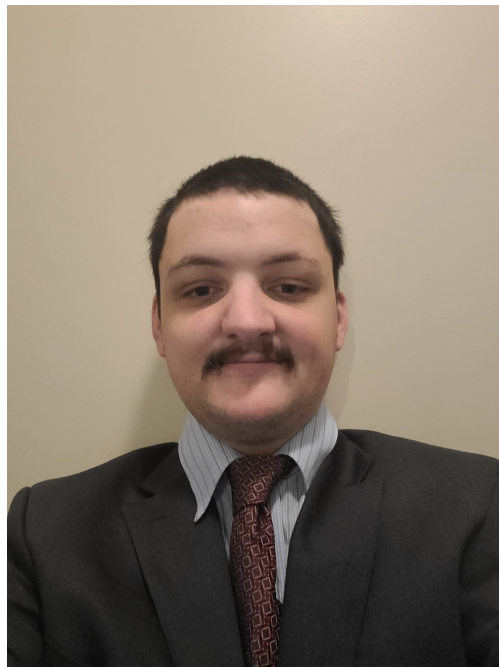

Q. Finish this sentence: Ordering an iced coffee in freezing temperatures is...

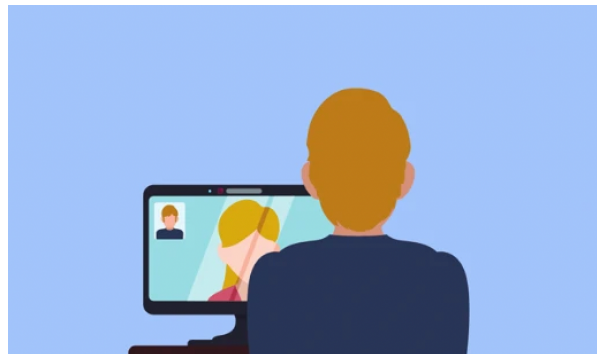
