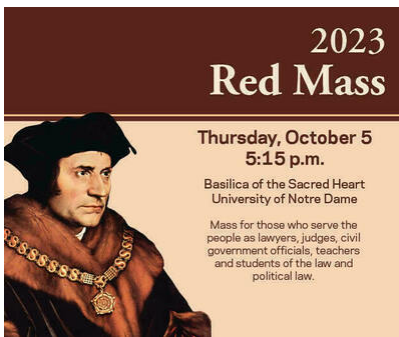
The Latest News

Exoneration Justice Clinic receives \$3 million grant to defend Mexican nationals in U.S. criminal cases



Notre Dame Law School's Exoneration Justice Clinic has been awarded a \$3 million grant to administer a program for the defense of Mexican nationals in criminal matters in the United States ("PDM"). This grant is the largest ever received by a Notre Dame Law School clinic, and it will greatly enhance the Exoneration Justice Clinic's ability to support clients and provide valuable learning opportunities for students.
