ND Law Professor Daniel Kelly appointed dean at University of St. Thomas School of Law

Notre Dame Law School Professor Daniel Kelly has been named the new dean at the University of St. Thomas School of Law. Kelly will begin his role on July 1, 2024.

“Professor Kelly is one of the nation’s leading scholars of



law and economics, and a leading thinker with respect to property and real estate,” said G. Marcus Cole, the Joseph A. Matson Dean and Professor of Law at Notre Dame Law School. “He has been an outstanding educator, dedicated to the Catholic mission of Notre Dame, and to the whole formation of our students. He is also a dear personal friend of mine. Although his absence will be deeply felt, we know that he will be a remarkable leader and a transformative dean. As he embarks on this new chapter, he goes with our heartfelt prayers for God’s blessings for him, his family, and his work.”

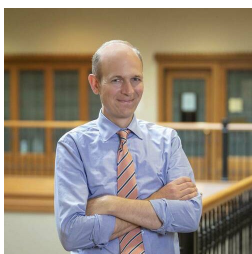

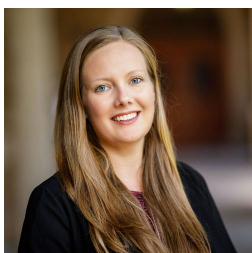

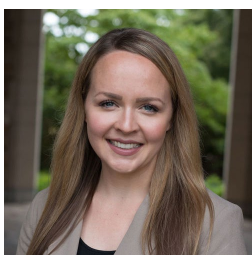


Derek Muller was quoted by [Fox News](#), [Des Moines Register](#), and [USA Today](#) about Iowa's ballot challenges for Donald Trump.
