New residence halls construction zone to limit walkway access

Phase 1 construction work on two new undergraduate residence halls will limit pedestrian walkway usage on the east side of campus in the coming months. Beginning Thursday, March 19, students, faculty and staff will no longer be able to enter or exit campus using the walkway that extends from Bulla Road, between the B2 Lot near the Wellness Center and the McCourtney Hall research building work site.
