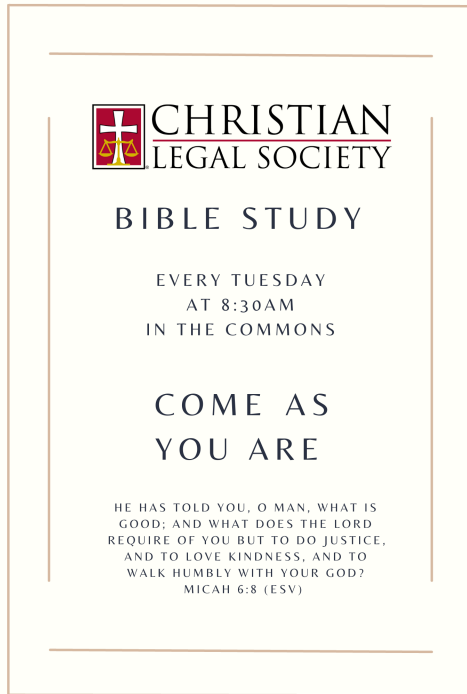

## **Announcements from the Kresge Law Library**

### **Study Rooms**

As we near the final exam period, remember that the Law Library has study rooms available for individual and group study. Reservations are highly recommended and must be made online. Reservations can be made for up to four hours at a time with one reservation per day, no more than one day in advance. Please be aware, the library Food and Drink policy also applies in the study rooms (only covered drinks allowed, no food). ### **Food in the Law Library**

A gentle reminder concerning the Food and Drink policy for the Kresge Law Library. Covered drinks are allowed throughout the Law Library, but please leave the lid on if you are sitting at a table to help avoid spills. Light Snacks that are not damaging to the collection or distracting to others are allowed ONLY in the South Reading Room (adjacent to the Main Reading Room) on the second floor. Please go to the Commons to eat your meals (sandwiches, pizza, soup, burgers, fries, salads, etc.) or any food which has a strong odor or that leaves a residue such as grease or crumbs behind. These policies also apply in the Law Library study rooms. Thank you for helping to keep our library clean and pest free!

### **Study Aids**

As you outline and prepare for finals, consider taking advantage of the Kresge Law Library's study aids, from Civil Procedure: Examples and Explanations to Business Associations in a Nutshell. Our current editions are on Reserve, available for 2-hour checkout. Please visit the circulation desk to look through our binder that includes several study aid lists arranged by series (Concise Hornbooks, Examples and Explanations, Hornbooks, Nutshells, and the Understanding Series).

We also subscribe to CALI, which provides lessons for law school courses and tutorials and podcasts to help students prepare for final exams. You will need to register for access, and the registration codes are available at the circulation desk.

### **Saint of the Week: St. Juan Diego with Brett Cavanaugh**

After teaching in Catholic schools near the Texas/Mexico border and developing a devotion to Our Lady of Guadalupe, my wife and I visited Mexico City in March. Saint Juan Diego was an indigenous peasant born in present-day Mexico City in 1474. He converted to Catholicism in 1524, shortly after the Spanish conquest. Our Lady appeared to Juan on December 9, 1531 on Tepeyac Hill. Notably, she appeared as an indigenous woman, speaking his native language and requesting that the local bishop build her a shrine. Though Juan shared the Blessed Mother's message, the bishop requested evidence of the apparition.

On December 12th, Our Lady appeared again and told Juan to fill his cloak, or tilma, with the flowers miraculously growing in the winter on Tepeyac Hill. Juan collected roses, returned to the bishop, and opened his tilma to reveal an image of Our Lady imprinted there. With this evidence, the bishop built a shrine on Tepeyac Hill that has become a popular pilgrimage site. Today, Guadalupe is venerated throughout Mexico as a symbol of God's care for the Americas during a particularly turbulent time and a reminder that in all places, at all times, God speaks to us in ways that we will understand.

Juan's tilma remains on display behind the altar in the Basilica of Our Lady of Guadalupe, and beautiful flowers continue to grow at Tepeyac, nearly 500 years after Our Lady appeared to Juan. In March, my wife and I climbed Tepeyac Hill and attended mass in the Basilica. Despite being in the largest city in North America, and surrounded by thousands of other pilgrims, we felt a sense of profound peace.
