LAMB EBEAL Conference 2024

Avishalom Tor organized the fifth ND LAMB Empirical, Behavioral, and Experimental Analyses of Law conference (EBEAL 2024) on March 7 at the London Global Gateway. Previous EBEAL conferences took place at the Tantar Gateway and Tel Aviv University (2022), the Dublin Gateway (2015), the London Gateway (2014), and Tel Aviv (2012).
