## **Liberty Clinic**

On April 2, the Oklahoma Supreme Court heard argument in *Drummond v. Statewide Virtual Charter School Board*, a lawsuit in which Attorney General Gentner Drummond asked the Oklahoma Supreme Court to block the State of Oklahoma from contracting with St. Isidore of Seville Catholic Virtual School to expand educational choices for families simply because the school is religious.

The Notre Dame Law School Religious Liberty Clinic represents St. Isidore, alongside a team of attorneys from Dechert LLP and Perri Dunn PLLC. A team of lawyers and students from the Religious Liberty Clinic traveled to Oklahoma City for the oral arguments. The students included Nick Grandpre, Charlie Nugent, and Hadiah Mabry.
