The inaugural GDC will see the Kellogg Institute convene leading defenders of global democracy at the University of Notre Dame for a series of profound, actionable conversations about the state of democracy around the world. Animated by our understanding of the multidimensional, complex nature of democratic erosion, this conference will identify emerging challenges to democracies and possible solutions, the research being undertaken by Notre Dame in order to have meaningful impact in the world of policy, convene global actors that will help lay the foundation for partnerships with institutions and leaders who might utilize our research in protecting local democratic structures.
