The Congressional Research Service provides policy and legal analysis to members of Congress and congressional committees, and it publishes reports on a range of policy issues. These reports are typically comprehensive and well-documented, offering both a solid overview of a legal topic as well as citations to primary authority. Reports may focus, for example, on one or more cases, a piece of legislation, an area of law, or international matters. Here are a few recent examples of the wide range of topics CRS covers:

St. Stanislaus Kostka (aka St. Stan), bishop and martyr, is known as the patron saint of Poland for his loyal adherence to the church despite the Polish king's immorality and corruption. (TLDR: He's the Polish version of St. Thomas More).

St. Pope John Paul II remarked, "Saint Stanislaus has become, in the spiritual history of the Polish people, the patron of this great and fundamental test of faith and of character [referencing the Sacrament of Confirmation]. In this sense we honor him also as the patron of the Christian moral order."

We are blessed to have a church right here in South Bend named St. Stanislaus! A good handful of law students regularly attend Mass there so you are sure to see a familiar face at 415 N Brookfield St.
