Justice Prevails as ND Law's Exoneration Justice Clinic Helps Exonerate Anthony Bedolla After 14-Year Wrongful Conviction



Anthony Bedolla, a Mexican national and client of Notre Dame Law School's Exoneration Justice Clinic (EJC), was exonerated this week after spending 14 years in prison for crimes he did not commit. The Marion County Superior Court vacated his convictions this week after new evidence cleared him of the crimes. The EJC investigated this case in collaboration with the Marion County Prosecutor's Office (MCPO) Conviction Integrity Unit (CIU) for almost two years. Read more here.
