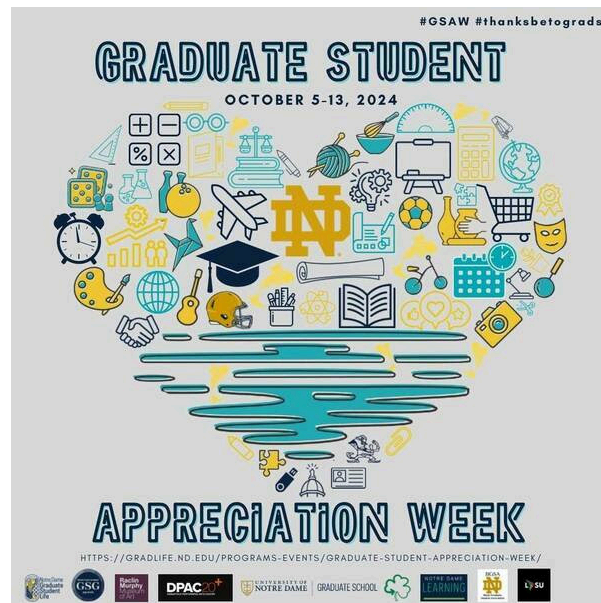

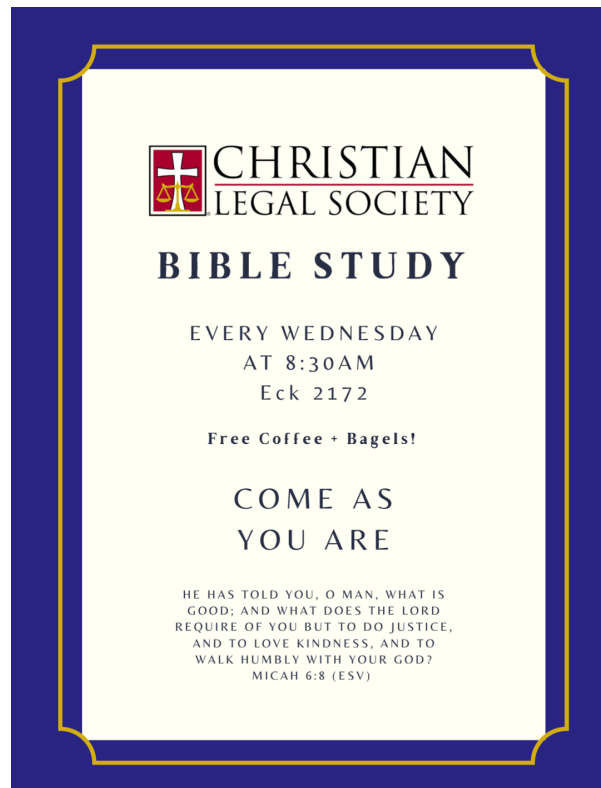

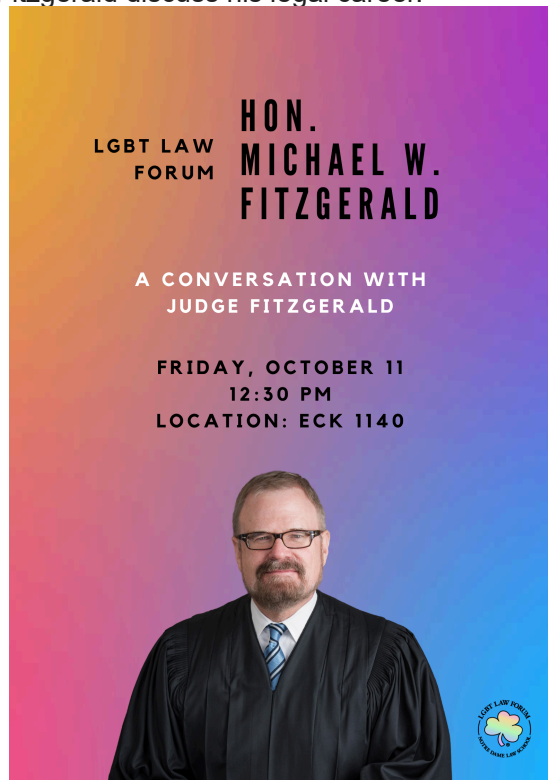

Saint of the Week:

Saint of the Week: St. Maria Goretti with Maria Valera



Saint Maria Goretti, the patron saint of adolescent girls, poverty, purity, and forgiveness, was born on October 16, 1890 to a peasant family in Corinaldo, Italy. Her father passed away when she was nine, so Maria, her mother, and her six siblings moved onto Giovanni Serenelli's land to find work. It's said that Maria was loved by the villagers, and that she was very pious; she recited the five Mysteries of the Rosary every night. After a while, Alessandro, Serenelli's son, began to harass Maria Goretti. He attempted to sexually assault her, but when she fought back and refused to submit to him, he stabbed her fourteen times. Her family found her gravely wounded, and rushed her to the hospital. She survived for twenty hours after the attack, and said that she forgave Alessandro for what he had done to her, "Yes, for the love of Jesus I forgive him...and I want him to be with me in Paradise." Maria then succumbed to her injuries and died at age eleven.

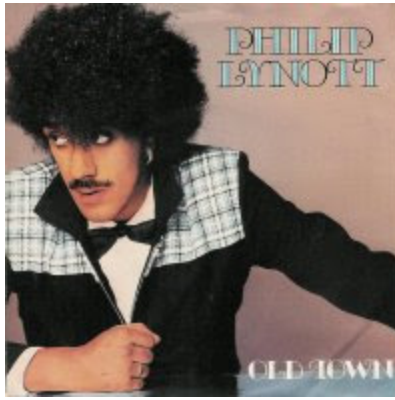
Alessandro was convicted of her murder and sent to prison. He claimed to have seen a vision of Maria, who offered him a bouquet of white lilies. This is why she is often pictured holding white lilies. After his sentence, he begged Maria's mother for forgiveness, and worked in a monastery for the rest of his life as a lay brother. Alessandro, along with thirty other witnesses to her sanctity, advocated for her canonization. St. Maria Goretti was canonized in 1950.

St. Maria Goretti's life and death reminds us of the incredible and restorative power that forgiveness and our love of Jesus Christ gives us. Despite all of the hardships Maria endured, she still held the strength to forgive her own murderer and even hoped to see him in heaven with her. She serves as a true model for what we as Christians should cherish greatly – our capacity to forgive through our Lord Jesus Christ.

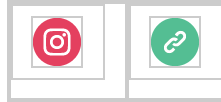
