Important: 2016 Enrollment is Required. *Because there have been significant changes to the University's benefit offerings, 2015 medical plan elections will not roll forward to 2016. To participate in a 2016 medical plan, benefit-eligible faculty and staff must enroll at MyBenefits.nd.edu between Oct. 20 and Nov. 6, 2015. If you do not enroll, you will not have a University medical plan or a flexible spending account for 2016, nor will you be able to participate in the new accident insurance or critical illness insurance benefits.*
