New York: New York University Press, 1959. Pp. xx, 106. \$2.75.
Islamic law is examined as a living social phenomenon developing rapidly at the present time.

Brooklyn: The Foundation Press, 1959. Pp. xxii, 613. \$8.00.

Washington: Public Affairs Institute, 1959. Pp. viii, 102. \$2.00. An analysis of the three postwar recessions in United States history aimed at the development of a long-range policy to prevent new recessions or at least stop them in their earliest phase.

Danville: Interstate Printers and Publishers, 1959. Pp. 181. \$3.00. The eleventh in a series of yearbooks of school law reviewing and analyzing the most significant court decisions dealing with schools and school districts in the higher state and Federal courts.

- PRICE DISCRIMINATION IN PROPERTY AND LIABILITY INSURANCE. By C. Arthur Williams, Jr.
Minneapolis: University of Minnesota Press, 1959. Pp. vi, 100. \$2.50. An analysis of the various facets of premium discrimination in the fields of property and liability insurance. The author discusses the several rating methods available, dividend structures, group insurance plans, the practice of pricing in concert and the various state statutes regulating liability and property insurance.

New York: Columbia University Press, 1959. Pp. vii, 271. \$2.50. The summary records of the eleventh session of the International Law Commission of the United Nations.

JURISPRUDENCE

- THE ELEMENTS OF LAW. By Thomas E. Davitt, S.J.
Boston: Little, Brown and Company, 1959. Pp. xxi, 370. \$9.00. An introductory book on the philosophy of law which attempts to trace the outlines of a coherence between a means-end philosophy of life and the philosophy of law. Cases are used to show judicial thinking on many points

and the text is designed to afford students examples of the application of principles to problems.

THE CONSTRUCTION WORKER UNDER FEDERAL WAGE LAWS. By Joseph M. Stone and John R. Brunozi.

Washington: Livingston Press, 1959. Pp. 129. \$4.00. An explanation and interpretation of the federal wage laws relating to the construction industry. The authors attempt to answer the questions which union and trade association officials, business agents, contractors and subcontractors might normally ask.

CONTINUING LEGAL EDUCATION FOR PROFESSIONAL COMPETENCE AND RESPONSIBILITY. By the Joint Committee on Continuing Legal Education of the American Law Institute and the American Bar Association Journal.

NON-PROFIT ASSOCIATIONS

UNINCORPORATED NON-PROFIT ASSOCIATIONS: THEIR PROPERTY AND THEIR LIABILITY. By H. A. J. Ford.

New York: Oxford University Press, 1959. Pp. xxii, 151. \$4.00. A critical and comparative study of Anglo-American law relating to unincorporated associations, societies and clubs which are not organized for profit. It deals with the effect of dispositions of property to such groups, the personal liability of members in contract and tort, and the liability of the group's common fund.

PROPERTY

PITFALLS OF ZONING: A GUIDE FOR ATTORNEYS. By the Home Title Guarantee Company.

New York, 1959. Pp. 39. A monograph which seeks to answer three principal questions for attorneys — (1) How does zoning affect title to real property? (2) What problems does this create for lawyers? (3) How can these problems be managed? Although the primary concern is with zoning in the State of New York, citations of decisions in other states are used at times to support certain points.

SOCIAL WORK

CONFIDENTIALITY IN SOCIAL WORK. By Joseph T. Alves, M.S.W.

Washington: Catholic University Press, 1959. Pp. xvi, 268. \$3.00. One of several basic concepts of social work, namely the principle of confidentiality, is examined from three points of view — (1) social work theory and practice, (2) principles of natural moral law or moral philosophy, (3) prescriptions of civil law and legal philosophy.

TRIAL TECHNIQUE

THE VOICE OF MODERN TRIALS. Vol. I. By Melvin M. Belli.

Indianapolis: Bobbs-Merrill Company, 1959. \$15.00. An album of three LP records (33 1/3 RPM) totaling three hours. Mr. Belli re-creates the actual opening statements and arguments from three recent cases, involving personal injury and wrongful death, in which he recovered for his clients a total of \$467,120.50.
