## THE COLLEGE OF LAW

---

**REGISTRATION:** In September, 1933, the registration in the College of Law was 118. In February, 1934, it was 106. In September, 1934, the registration was 123. This is an increase of 4.2% over September, 1933, and 16% over February, 1934. Twenty-two states and one foreign country are represented. 30% of the students are from Indiana, 20% from Illinois, 10% from Ohio and 8% from Michigan.

**FACULTY:** There have been no changes in the full time members of the faculty.

**THE LAW LIBRARY:** Larger tables have been provided for the reading room. The capacity has been increased by 50%. The system of lighting has been changed. Instead of relying for light on general
