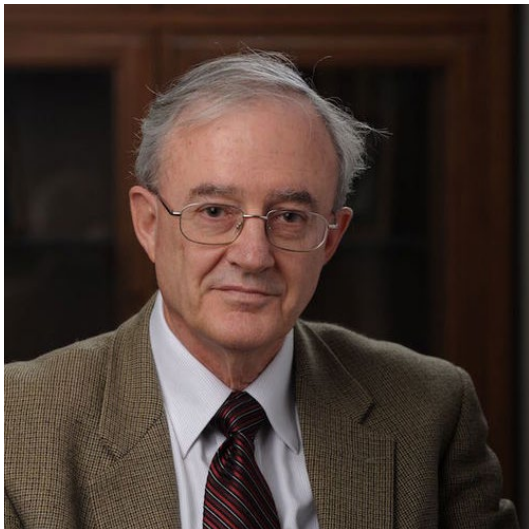

Wellness Screenings


