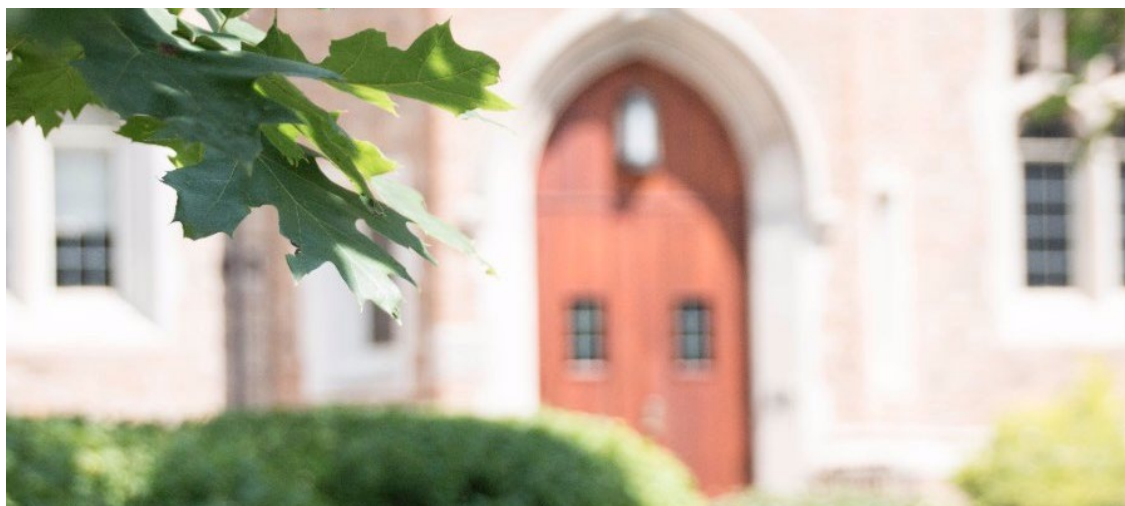

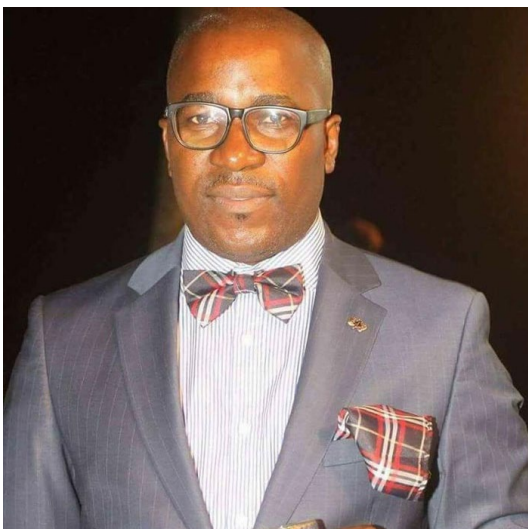


Student Summer Experiences
