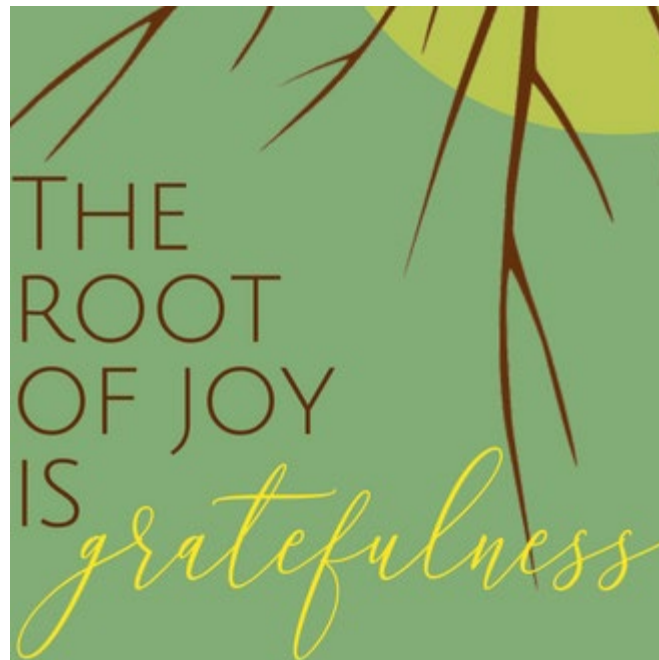
In Sympathy
