Sam Bray testifies on Supreme Court case selection

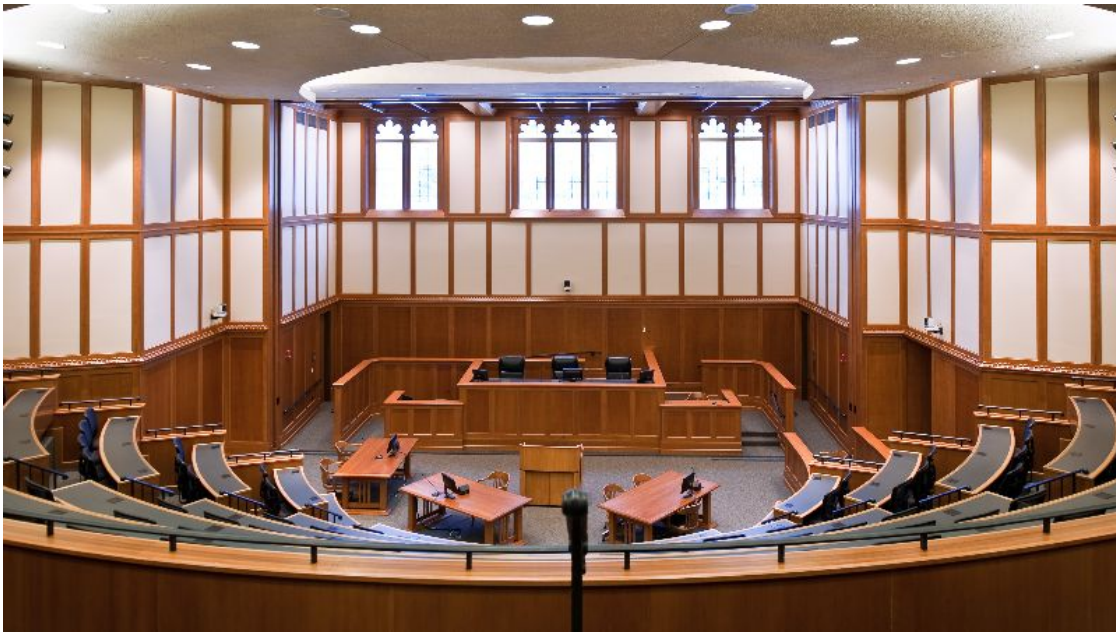
Sam testified before the Presidential Commission on the Supreme Court of the United States earlier this month.

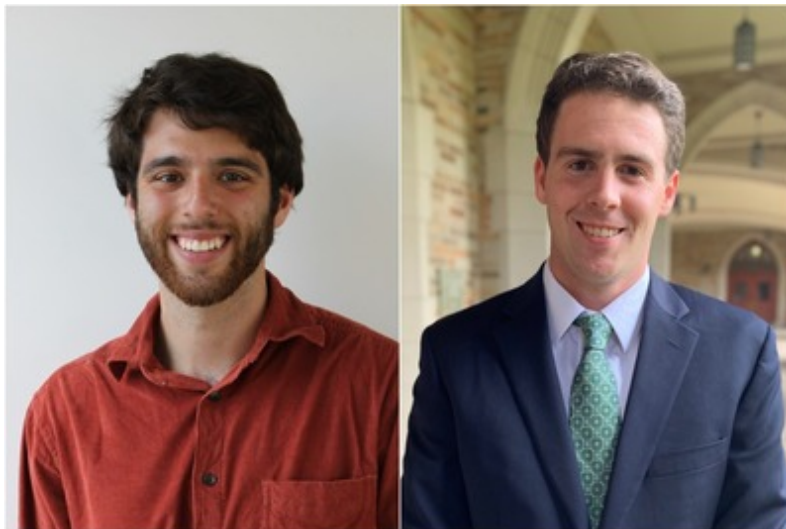
